## **Flagpole Limited Warranty**

Your purchase includes the following limited warranty. This warranty is extended to the initial consumer end user only. Warranty registration is not required.

**Flagpole & components:** The entire flagpole & components are under warranty to be free from faulty materials and workmanship from the date of the original purchase for 2 years. This warranty is extended to the life of the flagpole as long as the consumer continues to purchase flags annually from Flag Outlet. When regular annual flag purchases cease, flagpole warranty will cease at that same time.

Transportation charges for any flagpole or attachment are the sole responsibility of the purchaser. Transportation charges for any part submitted for replacement under this warranty must be paid by the purchaser.

General wear and tear of flagpole & parts are covered under warranty.

Any normal wear and tear on flagpole finish is not covered under warranty.

If the flagpole or parts should break due to faulty materials or workmanship during the warranty period, the flagpole/part, respectively, will be replaced without charge to you, subject to the Conditions of Warranty at the discretion of Flag Outlet. LABOUR IS NOT COVERED UNDER WARRANTY.

**OTHER PARTS:** All other parts of the flagpole, are under warranty to be free from faulty materials or workmanship for a period of two (2) years from the date of purchase by the original consumer purchaser, subject to the Conditions of Warranty.

If any part fails to function properly due to faulty materials or workmanship during the warranty period, such part will be replaced, you will no incur any cost for the replaced part, but may be subject to labour and/or shipping charges, this is subject to the Conditions of the Warranty and the discretion of Flag Outlet.

This warranty does not cover damage caused by improper storage of the flagpole, shipping damage, damage caused either accidentally or deliberately by you or another, and damage caused as a result of using the flagpole other than for it's intended purpose.
